STATE OF TEXAS \$ \$ KNOW ALL PERSONS BY THESE PRESENTS: COUNTY OF HARRIS \$

WHEREAS the CYPRESS TRAILS COMMUNITY IMPROVEMENT ASSOCIATION ("Association") is charged with administering and enforcing those certain covenants, conditions and restrictions contained in the recorded Declarations for the various sections of the community (referred to collectively as "Declarations"); and

WHEREAS chapter 202 of the Texas Property Code was amended, to add Section 202.023 thereto regarding Security Measures; and

WHEREAS, the Board of Directors ("Board") of the Association desires to establish guidelines for Security Measures consistent with the Section identified above in order to provide clear and definitive guidance to property Owners.

NOW, THEREFORE, the Board has duly adopted the following, Security Measure Guidelines.

- I. An Owner can build or install security measures, including but not limited to:
 - (1) Security camera. The security camera cannot be installed in a place other than the Owner's private property;
 - (2) Motion detector. If the motion detector has lights that come on when motion is detected, the lights must not shine into the neighbors' residence; and
 - (3) Perimeter fence. The type of fencing must be approved by the Association before it is installed.

The guidelines are effective upon recordation in the Public Records of Harris County, and supersedes any guidelines for security measures which may have previously been in effect. Except as affected by Section 202.023 and/or by these guidelines, all other provisions contained in the Declarations or any other dedicatory instruments of the Association shall remain in full force and effect.
